

Telehealth procedure codes for COVID-19

For Blue Cross (commercial) PPO, Medicare Plus BlueSM PPO,
BCN HMOSM (commercial) and BCN AdvantageSM members

Revised May 20, 2020

This document shows the codes associated with telehealth procedures covered with no cost sharing for members during the COVID-19 pandemic for Blue Cross (commercial) PPO and BCN HMO (commercial) members for dates of service on and after March 16, 2020, through June 30, 2020.

Cost sharing is waived for Medicare Plus Blue PPO and BCN Advantage members** for dates of service on and after March 16, 2020, through December 31, 2020.

Telehealth services that are covered under the Blue Cross and BCN Telemedicine Services Medical Policy that are not listed in the codes below, are still covered but will require standard member cost sharing.

Telehealth procedure codes									
Use Place of Service 02-Telehealth and modifier GT or 95 to indicate that the service rendered was actually performed via telehealth. Cost share is waived for participating commercial providers and participating and nonparticipating Medicare Advantage providers, per CMS Waiver 1135. All lines of business covered.									
During the COVID-19 pandemic, providers can temporarily use POS equal to what it would have been had the service been furnished in-person instead of using POS 02. The modifier is still required to ensure that cost share is waived.

Telehealth procedure codes

Use POS-Telehealth and modifier 95 to indicate that the service rendered was actually performed via telehealth. Cost share is waived for participating or nonparticipating providers, per CMS Waiver 1135. – Medicare Plus Blue PPO and BCN Advantage only (excludes commercial)

During the COVID-19 pandemic, providers can temporarily use POS equal to what it would have been had the service been furnished in-person instead of using POS 02. The modifier is still required to ensure that cost share is waived.
