## Potential Barriers to Learning: Cultural Norms & Faux Pas

### Gender Roles

Women as care givers

Men more resistant to health care

Children as care givers

## Body Images

More voluptuous bodies are desirable

Traditionally men view smaller body types as inadequate

Robust body type identified with health and ability to reproduce

# Communication Patterns: Regionally-Fixed Rhythms

- Decrease from North to South (eg., NY, MI, Miss.)
- May conflict with provider's patterns
- May create difficulty with effective patient/provider communication
- May determine amount of time spent with patient

#### Minimize the Risk of Mistakes

- **1.Avoid** using slang and idioms, choosing words that will convey only the most specific *denotative* meaning;
- 2.Listen carefully and, if in doubt, ask for confirmation of understanding (particularly important if accents and pronunciation are a problem);
- 3. Recognize that accenting and intonation can cause meaning to vary significantly; and
- 4.Respect both verbal and nonverbal communication formalities and styles, and watch for any changes in body language.

## A.S.K the Right Questions

#### Attitude

Enhance understanding of attitudes, behaviors and beliefs of underserved patient populations as an important factor in health disparities.

Recognize the need to screen for cultural barriers to care and/or adherence to treatment plans.

Communicate respect for culture to strengthen the patientprovider relationship.

## Skill

Augment observational and listening skills to increase sensitivity to visual or spoken cues.

Empower the patient to teach during the interview process by acknowledging the patient as the subject matter expert on "themselves".

Know questions to ask to assess the patient's perspective of the etiology, duration and expected treatment of their condition.

## Knowledge

Gain increased understanding of various historical, political and social events and issues that serve as contributing factors to health and health care disparities for underserved populations.

Know health racial and ethnic demographics and distribution of the service area.

Know the underlying factors and barriers that can have an impact on health-related outcomes.

Worlds Apart: Case 3 Mr. Robert Phillips Robert Phillips, a health policy analyst who is African-American, believes he's likely to wait twice as long as a white patient for his needed kidney transplant. He's looking for a new nephrologist – someone who will be more sensitive to his concerns. 10 Minutes

#### Different Attitudes Toward Disclosure

Issues of Trust between Patient and Provider

Degrees of Frankness

Nature of the Information

Age or Gender of the Informant

Perceived Value of Cultural Norms or Home Remedies

#### Explanatory Models

- 1. What do you think caused your problem?
- 2. Why do you think it started when it did?
- 3. What do you think your sickness does to you?
- 4. How severe is your sickness? Do you think it will last a long time, or will it be better soon in your opinion?

## Explanatory Models

- 5. What are the chief problems your sickness has caused for you?
- 6. What do you fear most about your sickness?
- 7. What kind of treatment do you think you should receive?
- 8. What are the most important results you hope to get from treatment?


